Old Business

Drug Shortage – Dr. Lindstrom reported we are having shortages of Epi, Cardizem and Normal Saline.

IRB – Dr. Lindstrom reported no update on the IRB.

ESO – Dennis reported we are waiting for Oregon to move forward.

Chief Gonzalez reported Toledo Fire has activated the positive ID this morning. Will let you know how it goes. Dennis reported we are holding off until mid April or the first of May. We have a meeting scheduled with the Board of Pharmacy before we activate it.

Opiate Epidemic – Dr. Lindstrom reported no change on opiate. There is a lot of community support on the aspects of this.

Masks – Jon Ziehr reported the P-100 masks have been distributed to the life squads. They are supposed to filter out the dust from the drugs. Dr. Lindstrom reported they are expensive and to only be used when suspected opiates are involved.

Clot Removal – Dr. Lindstrom reported we have extended our protocol to 24 hours in Dispatch but have not trained the Paramedics yet. It will be put in place in.

New Business

Toledo Hospital & EC – Kristie reported at Toledo Hospital a security analysis was done and a new procedure is being implemented for pre-hospital to enter the EC. Moving to a card swipe process. No date yet to go live. Kristie asked for other ideas from anyone to be passed on.

Pediatric Workshop – Kristie reported Toledo Hospital has been asked by the State in conjunction with OAEMS Children Safe Committee to host a pediatric workshop. It will be held June 27th at the ProMedica learning lab at Arrowhead.

Active Shooter – Brent reported Maumee Fire and Police have teamed together for an Active Shooter program. Brent also mentioned there is a tabletop on May 4th involving Toledo Fire, Toledo Police and Toledo Public schools. Later in the year they want to hold a full exercise. Brent also reported Toledo Police can only commit to one class a month which holds sixteen people.

LS cancellations – Dr. Lindstrom reported we are working with Dispatch to decrease the number of times a life squad is dispatch and cancelled. The goal is to get the cancellation rate down.

Dr. Lindstrom reported Toledo Fire is poised to have a paramedic on each engine at which point we could initiate the changes on a trial basis. Dr. Lindstrom said there is no scheduled start date.

State Board of Pharmacy – Dennis reported the State Board of Pharmacy hired new inspectors and they are more aggressive with their inspections. They visited Maumee Fire and identified several operational issues. One of the issues is there are two drug licenses with one vehicle. The Board has stopped inspections until it is resolved. Also there was discussion with them regarding our drug bags citing drugs could be taken out even with them tagged so we are replacing the bags with hard cases. They also questioned our re-supply of the ALS bags. EMS has a meeting scheduled to discuss the issues with the inspector.

There is the suggestion of getting waivers for dual pharmacy licenses.

Dennis also reported they want positive ID with oxygen and saline use. They want ESO to track all drugs and oxygen. ESO currently does not have oxygen or saline for positive ID.

Brent reported the inspectors want to see a set up with a fire department that has a first responder, an ambulance and a life squad and since they have been to Maumee, this is where the meeting will be held.

Dennis reported we have reached out to ESO about adding oxygen and normal saline and ESO will reach out to the Pharmacy Board to get clarification.

Adjournment – With no further business, the meeting was adjourned at 9:02 a.m. The next meeting will be June 4th at 8:30.
