**Call to Order**

The meeting was called to order by Chief Ramm at 9am.

**Minute Approval**

The minutes from the May 9, 2022 meeting were distributed for review. Chief Ramm motioned and Chief Homik seconded. Meeting minutes were approved.

**Old Business**

Dr Lindstorm said nothing has changed with items discussed at last meeting.

Brent is filling in for full time CE position. The position has been posted. Brent gave an update on paramedics who need to do make-ups for April as well as May. July 20 is the deadline. Brent will send a reminder this week.

## **New Business**

Dr Lindstrom gave update on issue with St Lukes having correct status posted for bypass. He has spoken with Cheryl Herr, who is working with new staff to make sure they know how to handle the status board.

Dennis said LS 4 had an accident over the weekend. Takes it out for a very long period of time. There has been discussion of why are we going code red lights and sirens. Need to revisit the discussion of when we need to go code red. Studies indicate no benefits to going lights and sirens. Dr Lindstrom believes it needs to be discussed between the Lucas County fire chiefs. There is concern patients may have the perception that we are not providing appropriate emergency response not going lights and sirens.

Chief Ramm said he will bring it to the fire chiefs at their next meeting. Dr Lindstrom will forward the current policy statement. Mark said they covered it in last months' CE. Chief Hartbarger said there is legislation potentially removing governments from immunity, bill 172. Is there a concern about areas where there are only volunteer departments, timing of getting to the scene is already an issue. Are accidents happening during code 3 runs?

Discussion about using rescue pump and switching to LUCAS device quicker than the 10 minute time frame. This would help reduce number of vehicles needed on scene. Dr Lindstrom is not sure if there is enough data to support this request. Brent said they have already altered the protocol for the pump, set time frame at 10 minutes when changed the protocol.

Information displayed in CAD dispatch information used to be more in depth. Is anyone else experiencing that issue? Seems to be an issue. There has been some discussion with Ralph, David Brown said he will continue those conversations. Dispatchers are all having to go through continuing education. Can using MDT buttons more free up some time to put more info in CAD system. Call taking function is under Jen. The time frame needs to be addressed, extra ten seconds even would be helpful. Dr Lindstrom does not believe that the 30 second time frame is the issue, the issue is the continued conversations with the caller after. Chief Hartbarger said if they allow the timing to go much higher it may affect ISO rating.

Dr Lindstrom said they are working on getting some protocol updates ready for the fall. They are figuring out training schedules now.
