Call to Order

Minute Approval

Old Business

ProMedica at home care program discussed. Dr. Lindstrom asked if there was any questions discussed with our legal team, Dennis has not had a conversation with legal. Dr. Brookens said he sent an email after the last meeting, will reach out again to discuss. Dr. Brookens said he will set up a small virtual meeting with Brent, Dr. Lindstrom, Dennis and Jon through Sky. Dr. Brookens said the program is still small because they are limited because of staffing issues.

Chief Ramm said there was another meeting on the paramedic internship program. A new draft will be sent to operating chiefs, the holdup has been the non-operating chiefs. They did a nice job with adjustments made for non-operating jurisdictions.

Dr. Lindstrom discussed changes at St Lukes, ER group will be changing, McLaren is going with a different group effective October. Specialty services are changing as well, lost RACE nurses, on indefinite RACE bypass, STEMI program affected as well. OB services are closing as of August 1st, waiting for official notice in writing.

New Business

Discussion of medication shortages. Sitting on a supply of dextrose that is not huge but we never know when a shipment will come in. Preventative maintenance with stretchers. Bariatric cot is down – waiting for Stryker to get parts to fix.
