### **AUTHORIZATION FOR TEXT-MESSAGING AND/OR EMAIL NOTIFICATION**

**TEXT-MESSAGE NOTIFICATIONS:** The Lucas County Juvenile Court has the ability to send you text-message and/or e-mail notifications when hearings are set, as well as reminders leading up to the hearing. This also includes emergency closing notifications. The Court encourages all persons with a pending case in the Juvenile Court to opt-in to this service.

**SUMMARY TERMS & CONDITIONS:** Our mobile text-messages and e-mail notifications are intended for individuals with business with the Lucas County Juvenile Court. You may receive multiple messages per month depending on the hearing activity of your case(s).

**MESSAGE & DATA RATES MAY APPLY.** The service is available to persons with text/email-capable phones subscribing to various carriers including, but not limited to AT&T, Verizon Wireless, T-Mobile, Sprint, Boost, etc. For help or to stop text and/or email notification, please call our Clerk's Office at (419) 213-6722.
